Broadway Bound is a new 9-month program addition to the Imagine Youth Theater workshop program featuring dance, voice(choral), acting/musical theater, dance (ballet/jazz/tap) classes and special monthly guest artist workshops.

This program is in addition to the Imagine Youth Theater workshops and participation is required in at least 2 of the 3 workshops offered during the season timeframe. (Fall, Winter, and Spring).

Broadway Bound faculty features:

Program Director: Carol Johnson

Dance Instructor: Carol Johnson

And a rotating guest faculty:

Voice/Choral Director, Choreographer, Workshop Director and Assistant, Guest Artists.

On Saturdays, once monthly, except December and March, a special themed musical theater workshop will be held featuring professional guest artists.

Participant commitment is for the full season. Minimum 8 – must submit registration package and registration fee by August 15<sup>th</sup>.

Tuition may be paid in full or by monthly auto-draft on a credit or debit card. Payments in full qualify for a 5% discount, with the exception of Registration and Workshop Fee and is due August 15<sup>th</sup> for the 18-19 Season – 9 months. Monthly payments are due on the 1<sup>st</sup>, past due on the 5<sup>th</sup> and subject to a \$35 late fee after the 5<sup>th</sup>. Monthly fees not on auto-draft still require credit or debit card information on file as fees not received by the 5<sup>th</sup> will be processed through this card. Upon enrollment, financial responsibility is assumed for all Broadway Bound fees regardless of early withdrawal. These fees are non-refundable.

<p><b>CLASSROOM</b></p>	<p>Only water is allowed in the classroom. Parents are welcome to wait in the designated area provided but are not allowed inside the classroom as it is very distracting for the actors.</p>
<p><b>CLASS ATTIRE</b></p>	<p>Black jazz shoes are preferred and recommended for rehearsal due to dance floor in studio, but black shoes are required for performance.</p>
<p><b>DANCE ATTIRE</b></p>	<p>ATTIRE: Girls: Leotard, pink tights, hair in bun. Guys: Black tights/jazz pants, black or white shirts. hair secured/off face. SHOES: Girls: Pink canvas split-sole ballet shoes, pink pointe shoes, black pedinis for jazz, black oxford style tap shoes. Guys: Black canvas split-sole ballet shoes, black split sole jazz shoes, black oxford style tap shoes.</p>
