FEES: REGISTRATION TUITION PRODUCTION	<p>ALL FEES ARE NON-REFUNDABLE. Initial: _____ REGISTRATION is paid once a calendar year.</p> <p>TUITION will be charged on the 1st of the month, past due on the 5th, and subject to a \$25 late FEE. June will be charged as a ½ month and MUST be paid in order to participate in the spring production.</p> <p>PRODUCTION FEES include costuming and production fees. Participation requires payment of all tuition. Fee may be made in two payments with ½ due Sept 5, balance due Nov 5. A set fee of \$225 is charged for those taking only one subject while those taking 2 subjects pay \$250. For those students participating in 3 or more subjects, the package price is the most economical way to go. Please note: performers will receive costumes only after all fees and payments have been satisfied. NOTE: While the PK Dance Program distributes costumes, all other costumes are considered the property of Taylor Dance unless otherwise determined.</p>
